California Dental Network Benefits Schedule and Policy Updates for 2023

Effective January 1, 2023

The American Dental Association has updated its Current Dental Terminology (CDT) for 2023. The Plan has updated all of its fee schedules to reflect the changes to the 2023 CDT. Some new procedures have been added as covered benefits on all Plans, some procedures are entirely new, and some have been modified and are replacing previously covered codes that have been removed by the CDT. The applicable fees apply to all Plan benefit schedules, subject to the Plan's Limitations and Exclusions. (Some of the Plan's Limitations and Exclusions are waived on Advantage Plans and Plans with the Cosmetic Benefits Rider).
